**Composite Description:** The MFS Canadian Equity Composite includes all discretionary portfolios managed to the MFS Canadian Equity strategy. The strategy seeks long-term capital appreciation by investing primarily in large-capitalization companies that are domiciled in or have economic ties to Canada that offer durable, above-average growth, financial strength and a consistent business model. Because the portfolio may invest a substantial amount of its assets in issuers located in a single country or in a limited number of countries, it may be more volatile than a portfolio that is more geographically diversified. Stock markets and investments in individual stocks are volatile and can decline significantly in response to or investor perception of, issuer, market, economic, industry, political, regulatory, geopolitical, and other conditions.

S&P/TSX Capped Composite - Comprises the majority of market capitalization for Canadian-based, Toronto Stock Exchange listed companies with the relative weight by market capitalization of any single index constituent is capped at 10%.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

Prior to 1-May-2017, the maximum institutional separate account fee charged for this product was 75 bps. From 1-May-2017 through 30-Jun-2020, the maximum institutional separate account fee charged for this product was 40 bps.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.
